OUR TRAIL WORK ENSURES THAT HIKERS, EQUESTRIANS, AND OUTDOOR ENTHUSIASTS HAVE SAFE, WELL-MAINTAINED TRAILS TO ENJOY WHILE ALSO ADDRESSING THE BACKLOG OF DEFERRED MAINTENANCE ON PUBLIC LANDS. A WELL-MAINTAINED TRAIL IS A KEY TOOL IN THE PROTECTION OF OUR PUBLIC LANDS -- KEEPING VISITORS OFF THE SENSITIVE FLORA AND REDUCING EROSION ON POPULAR TRAILS.
