We are committed to reducing barriers so youth from all backgrounds can experience the power of being outside. WTA's Families Go Hiking e-newsletter helps inspire 60,000 subscribers with tips and trips to create safe and enjoyable outdoor adventures for the whole family. In addition, WTA provides training and resources to help teachers and youth leaders offer outdoor experiences in their community. Last year, the pandemic meant we had to pause on our in-person events. However, this provided us the opportunity to reimagine leadership and training.
